

## Charter for providing accommodation to Ukrainian citizens

### Context:

On 7 March 2022, the European Commission activated the "temporary protection" directive to provide rapid assistance to people fleeing the war in Ukraine. The basic duration of the temporary protection is one year. Depending on the decisions taken by the European Union, it can be automatically extended for periods of 6 months for a maximum duration of one year. If there are still reasons to maintain the temporary protection, it can be extended again for a maximum period of one year. Temporary protection can therefore be applied for a period of 3 years.

The granting of this protection includes a right of residence, access to the labour market, access to housing and education. The beneficiary of the protection will have access to social security, subject to conditions related to each system (CPAS, family allowances, health insurance...).

This document aims to explain simply and in a non-exhaustive way the commitments related to the accommodation of Ukrainian nationals.

**BY SIGNING this Charter, the host COMMITS, as a citizen, to welcome and host people fleeing the war in UKRAINE in accordance with the VALUES and COMMITMENTS below.**

### VALUES:

The values of this charter are those of **SOLIDARITY, RESPONSABILITY, OPEN MINDEDNESS** and **RESPECT**.

### COMMITMENTS:

- The host commits himself on a voluntary basis and offers his help in a philanthropic way in the context of a citizens' initiative (with no desire to make a financial or in kind profit).
- The host provides either a whole dwelling or one or more rooms where the privacy of its occupants is guaranteed and which can be locked.
- The host offers accommodation that meets minimum safety and healthiness standards (including access to sanitary facilities and a kitchen)
- The host accepts visits to the dwelling by the various competent services;
- The host will ensure an environment without prejudice or preconceptions related to nationality, ethnicity, religion, gender or political affiliation.

Additional information:

- If the hosted person has a health problem, it is possible to contact a general practitioner because the status of "temporary protection" allows the beneficiary to register as a holder with the health insurance company.
- It is possible and highly recommended to sign an occupation agreement with the hosted person(s) in order to determine the accommodation practical arrangements, their execution and the means and deadlines to put an end to the accommodation of the occupants in the respect of the VALUES and COMMITMENTS of the present charter.
